**Resolution No. 2020-24
Supplemental Annual Procurement Plan No. 20 FY 2020**

WHEREAS, Section 7.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 states that no procurement shall be undertaken unless it is in accordance with the Annual Procurement Plan (APP);

WHEREAS, the Bids and Awards Committee (BAC), in coordination with the different end-user units in the Office of the Vice President, prepared the APP for FY 2020 and submitted the same to the Government Procurement Policy Board (GPPB) in accordance with Section 7.3.5 of the Revised IRR of R.A. No. 9184;

WHEREAS, subsequently, the BAC, through its Secretariat, received Project Procurement Management Plans (PPMP) from various units for their additional requirements for the period;

WHEREAS, Section 7.4 of the Revised IRR of R.A. No. 9184 states that any changes in the APP for the budget year shall be consolidated by the BAC for approval of the Head of the Procuring Entity (HOPE) and submitted to the GPPB in July of the current budget year, and in January of the following budget year;

WHEREAS, the Media Affairs Division conducted a market study and determined that a particular supplier (i.e., DDI-TDM Consultancy Corporation) could undertake the Media Monitoring Services project at more advantageous terms, consistent with Section 53.6 of the Revised IRR of R.A. No. 9184;

WHEREAS, Section 48.1 of the Revised IRR of R.A. No. 9184 allows agencies to resort to alternative modes of procurement in order to promote economy and

efficiency, such as Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services under Section 53.6 and Small Value Procurement under Section 53.9, subject to prior approval of the HOPE;

WHEREAS, the BAC delegated the authority to the Administrative and Financial Service Office to undertake Shopping, Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue under BAC Resolution No. 2016-007A dated September 23, 2016;

WHEREAS, the BAC Secretariat consolidated the PPMP into the Supplemental APP No. 2 for FY 2020 and submitted the same to the BAC for approval through referendum in consideration of the timeline for the project;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC resolved to recommend to the Chief of Staff the approval of the Supplemental APP No. 2 for FY 2020 (Annex C) amounting to One Hundred Ninety Six Thousand One Hundred Pesos (P404,158.00), under Section 48.1 of the Revised IRR of R.A. No. 9184.
